From the **Executive Committee**

2013 might not have been an official "Leap Year," but it certainly proved to be one for the NNN, Inc. It was a time of extraordinary growth, completion of long-term projects and expanded partnerships that brought the organization to entirely new levels of capacity and accomplishment.

At the heart of the year's achievements was the completion of a community-based planning process resulting in a comprehensive Near Northwest Neighborhood Quality of Life Plan, which you will learn more about in this report. Here we share other highlights of 2013.

- In the past year, the NNN rehabilitated six additional homes and impacted a total of 16 properties in strategically targeted areas.
- The NNN was delighted to welcome six new homebuyers to the neighborhood in 2013. Due to heightened interest in the neighborhood, the NNN has reestablished a waiting list for those desiring to move to the near northwest when NNN homes come available.
- An active participant in the City of South Bend's Vacant and Abandoned Property Task Force, the NNN was pleased to host the press conference for the roll-out of the Task Force report in an NNN-rehabbed property in late February. The NNN has also been instrumental in addressing Mayor Pete Buttigieg's "1000 homes in 1000 days" program.
- Partnering with the Englewood Group of Indianapolis, the NNN submitted its first tax credit application to the Indiana Housing and Community Development Authority in November. The proposal, which calls for redevelopment of the dilapidated Ford Distributing Building sparked high interest, drawing 140 neighbors to over nine community engagement sessions to discuss the project.



- The NNN completed the interior finishes of its new Community Space and hosted a "grand opening" in early October, quite fittingly for the rollout of the Quality of Life Plan. Since then, the space has been used for various community gatherings, as well as an Arts Café art gallery.
- The neighborhood had other significant "grand openings" as well this fall. The Diamond Avenue re-opening, after completion of the Storm Sewer Project, was cause for celebration throughout the neighborhood! In addition, the NNN hosted ribbon cuttings for two new locally owned businesses in the neighborhood: South Bend Drum and Music Exchange and My Photo Studio.



- Quality of Life Action Planning teams hit the ground running. The Economic Opportunity and Redevelopment Committee helped guide the Ford Distributing Building redevelopment proposal and shortly after the Plan roll-out, the Youth and Families Committee hosted six weeks of free ZUMBA classes in the new Community Space.
- In its 11th year, the 2013 Adopt-a-Block litter reduction program for the second time adopted EVERY block in the neighborhood well over 200 blocks!
- Four NNN general meetings and numerous committee meetings offered opportunities for residents to learn about area issues, including neighborhood infrastructure enhancements and effective use of South Bend's new Chronic Nuisance Ordinance.
- This year's Arts Café, which annually invites the broader community to our neighborhood for a celebration of arts, culture and architecture, featured six properties and a very popular first ever resident-run popup coffee shop in NNN space a harbinger of a future neighborhood coffeehouse!

2013 has been a year of exceptionally hard work and exceptional achievement for everyone that is part of the NNN. The Near Northwest Quality of Life Plan

The Near Northwest Neighborhood, Inc. (NNN) has a long history of resident engagement and participation, collaboration, and addressing needs by capitalizing on the neighborhood's many assets. Because of this, the "theory of change" associated with comprehensive community development is already thoroughly ingrained in the near northwest.

In 2013, guided by the generous technical assistance of Indiana Association for Community Economic Development staff, the NNN

> engaged residents and stakeholders in a community-based planning process, resulting in a comprehensive Quality of Life Plan for the entire neighborhood.

The process began in late 2012 with organizing. Neighborhood leaders and stakeholders were first trained to conduct one-on-one interviews with community residents. These volunteers then set out to listen to over 130 residents' hopes and concerns for the neighborhood's future. The results of these interviews were compiled and shared in a Report Back document and presentation in early March.

Neighbors next moved into deciding their vision for the neighborhood: Near northwest is a neighborhood of choice and seen as a highly desirable place to live, work, and play. Then, based on this vision and interview results, they defined the six key areas to be addressed in the plan:

- Connections and Communications
- Quality Housing
- Economic Opportunity and Redevelopment
- Infrastructure and Connectivity
- Youth and Families

Following the Quality of Life Planning Summit in early May, action planning teams formed and began the task of developing ambitious, achievable five-year goals and action plans in each of these areas.



Teams worked hard throughout the summer months and as fall set in, the neighborhood moved toward action - finalizing the Quality of Life Plan; rolling it out to neighborhood residents, business owners, and other stakeholders; and requesting the South Bend Common Council's endorsement. The completed plan, which was formally adopted by the Common Council on October 28, 2013, consists of a shared neighborhood vision, 20 goals and 99 action steps to make those goals a reality. With these important first steps complete, the real work of implementation now begins. The NNN will serve as the coordinating organization, but the plan's ultimate success depends on all of us in

the near northwest. There are substantive roles for EVERYONE and ample opportunities for private-public partnerships as well. Come join us - together let's make 2014 an exciting year of action!
