#### **SJC Emergency Rental** Assistance

s this Newsletter is being written, COVID-related Emergency Rental Assistance (ERA) funding has come to the County to provide back payments or forward payments of rent for tenants impacted financially by COVID related closures and work changes. Rent, and rental utility costs back owed since April 2020 may be covered, and also for some time in to the future. Up to twelve months of rent and utility assistance may be provided (including past due balances accrued after April 1, 2020), up to monthly published limits.

#### EMERGENCY RENTAL ASSISTANCE PROGRAM



Tenants will have to income gualify at 80% AMI or less, and demonstrate Covid related hardship. Tenants may apply for the program, and Landlords will be contacted for verification. However, assistance may be granted without Landlord participation. Landlords may apply on behalf of tenants, but tenants MUST be involved for the application to proceed.

#### Muessel School – What's Next

Beginning in the Fall of 2021, the NNN's Muessel school will be among the South Bend Community School Corporation's redesigned schools. The school has received a failing grade from the state of Indiana for numerous years.

The anticipated new school model is considered an Innovation Network Zone and was designed to improve academic achievement. This change will reflect an extended learning day, put an emphasis on stronger curriculum, and invest in school leader development and training, and identify community partners that support the redesign efforts.



The decision to reorganize the school was aligned with district's strategic focus of academic success, financial sustainability, and equity and inclusion.

At a virtual information session held specifically for the NNN last month Superintendent Cummings assured neighbors that Muessel would still be considered a neighborhood school and student selection will stay within this area. Who is eligible? Renters and homeowners who earn less than 80% of median income (\$56,650 for a family of 4).
